I am fully aware and thoroughly informed of the hazards of participating in basketball; further, I have read and fully understand the following: That participation is voluntary and at my/minor's own risk; That basketball is a physical activity involving heavy exertion. A player/participant must be in good general health, free from cardiovascular and respiratory disease, or other disease or ailments and have good exercise tolerance; That while participating in basketball, the human body is subject to a variety of influences that may become potentially hazardous.
